**Passage of House Bill 5 mandates new due dates as shown below.

This statement is for Mandatory Declaration of Estimated Tax for the **current tax year**.

Due ON or BEFORE...

Payments made using this form will be applied **ONLY** to the **current tax year**.

Who Must File:

- 1st quarter = April 15th
- 2nd quarter = June 15th
- 3rd quarter = September 15th
- 4th quarter = December 15th

(B)(1) Every taxpayer shall make a declaration of estimated taxes for the current taxable year, on the form prescribed by the Tax Administrator, if the amount payable as estimated taxes is at least \$200.00.

When to File:

Passage of House Bill 5 mandates penalty and interest fees be imposed for unpaid estimated taxes.

The declaration of estimated taxes shall be filed on or before the date prescribed for the filing of municipal income tax returns under division (G) of Section 5 or on or before the fifteenth (15th) day of the fourth month after the taxpayer becomes subject to tax for the first time.
